The authority for using the OEKO-TEX® STAND-ARD 100 mark "OEKO-TEX® CONFIDENCE IN TEXTILES – STANDARD 100 – Tested for harmful substances" is restricted to the applicant. Use of the mark presupposes a test report from a testing institute certifying the authorisation as well as issue of the following declaration.

Declaration

For authorisation to use the mark "OEKO-TEX® CONFIDENCE IN TEXTILES – STANDARD 100 – Tested for harmful substances" I declare as authorized person on behalf of my company.

1 Quality control

We have described to one of the testing institutes the precautionary measures taken within the company to ensure that all products manufactured and/or sold for which authorisation to use the mark "OEKO-TEX® CONFIDENCE IN TEXTILES – STANDARD 100 – Tested for harmful substances" has been granted do fulfil the conditions and criteria (depending on requested certification either according to Annex 4 or according to Annex 6) of the OEKO-TEX® STANDARD 100 (and of the possibly also applicable OEKO-TEX® LEATHER STANDARD) in the same way as the samples that have been sent to the institute, and based on those tests the authorisation has been granted.

2 Quality assurance

To ensure the conformity of the products manufactured with the sample material and/or sold we operate an effective quality assurance system and shall maintain it for the whole period of use of the mark "OEKO-TEX® CONFIDENCE IN TEXTILES -STANDARD 100 - Tested for harmful substances", thereby ensuring and proving to the OEKO-TEX® institute that the products from different processing batches or from different colours are spot-checked for compliance with the OEKO-TEX® STANDARD 100 conditions and criteria (depending on requested certification either according to Annex 4 or according to Annex 6) and as circumstances require are spot-checked for leather, skin or fur components, perhaps present in the certified article too, for compliance with the requirements of the then co-applicable OEKO-TEX® LEATHER STANDARD. Tests can be carried out at our works or at one of the OEKO-TEX® institutes.

对于使用"OEKO-TEX[®] CONFIDENCE IN TEXTILES-OEKO-TEX[®] ORGANIC COTTON-通过 有害物质检验"标签的授权,我谨代表公司郑重声 明:

品质控制

我们已向 OEKO-TEX[®]成员检测机构作出承诺,将 采取预防措施,确保所生产和/或销售的所有获准使用"OEKO-TEX[®] CONFIDENCE IN TEXTILES-ORGANIC COTTON-通过有害物质检验"标签的产 品均符合 OEKO-TEX[®] ORGANIC COTTON 的条件 和标准(基于申请依据附录 4 或附录 6 中要求), (以及可能适用的 OEKO-TEX[®] STANDARD 100 和 LEATHER STANDARD),与送测并通过测试获得 授权的样品生产方式相同。

品质保证

我司将实行一套有效的质量保证体系,以确保生产 和/或销售的产品与样品材质相同,并在"OEKO-**TEX**® CONFIDENCE IN **TEXTILES-ORGANIC** COTTON -通过有害物质检验"标签有效期内保持 致,并以此向 OEKO-TEX®协会成员机构保证和证 明不同批次或不同颜色的产品都可以通过 OEKO-TEX® ORGANIC COTTON 的抽检,符合认证条件 和标准(基于申请依据附录4或附录6中要求) 根据情况需要对认证产品中可能含有的皮革、皮或 毛皮成分进行抽检时,确保其符合共同适用的 和 LEATHER OEKO-TEX® STANDARD 100 STANDARD 的要求。检测可在我司进行,也可在任 意一家 OEKO-TEX®成员机构进行。



We document these tests by specifying:

- Date of testing
- Designation of the test sample (manufacturing batch, finishing batch, colour, etc.)
- Person responsible for the test
- Test results
- Random tests

Moreover we accept that the institute granting authorisation for use of the mark "OEKO-TEX® CON-FIDENCE IN TEXTILES - STANDARD 100 - Tested for harmful substances" is authorized to carry out random tests on each product under application in accordance with the original type twice a year until we indicate to the institute of OEKO-TEX® that production and/or sale has been discontinued and the mark "OEKO-TEX® CONFIDENCE IN TEXTILES - STANDARD 100 - Tested for harmful substances" is no longer used. The costs of testing are charged to us. If random testing reveals a deviation from the limit values on which the tests are based, an additional test shall be carried out on a different sample for the purpose of checking, and the relevant costs are likewise charged to us. If further deviations are found, the OEKO-TEX® institute responsible for the granting of the authorisation may withdraw the authorisation to mark the product with the label "OEKO-TEX® CONFIDENCE IN TEX-TILES - STANDARD 100 - Tested for harmful substances" with immediate effect. The use of existing advertising materials, displays, labels, etc. is limited to two months from the time of withdrawal.

However, in cases where at the control tests a severly/serious deviation from the underlying/required limit values is found, the testing institute and as the circumstances require also the OEKO-TEX® Secretariat has also the right, to withdraw the issued certificate and the authorisation to label the products with the OEKO-TEX® STANDARD 100 mark with immediate effect. In such cases it is also possible to prohibit the use of advertising materials, display lables, labels, etc. with immediate effect.

We acknowledge, that auditors from the testing institute are allowed to visit and audit the company in reference to the certification process according to OEKO-TEX® STANDARD 100. In case of noncompliance with the OEKO-TEX® STANDARD 100 requirements and criteria (depending on requested certification either according to Annex 4 **or** according to Annex 6), the cost for the analytical testing (control tests) and an audit fee have to be paid by us.

We acknowledge that the certifying institute or an OEKO-TEX[®] Auditor is entitled to check our company with reference to the quality assurance measures in respect of the certification process accord-

此外,我们接受"OEKO-TEX[®] CONFIDENCE IN TEXTILES-ORGANIC COTTON-通过有害物质检验" 标签授权机构,每年两次依据原送检产品对每种产 品进行随机检测,直至我司向该 OEKO-TEX®成员 机构声明终止生产和/或销售 , 并停止使用"OEKO-TEX® CONFIDENCE IN TEXTILES-OEKO-TEX® ORGANIC COTTON-通过有害物质检验"标签。检 测费用由我方承担。若随机检测的结果没有达到标 准限量值,将对其他样品进行追加检测,相关费用 也由我方承担。若其他检测结果也不达标, OEKO-TEX[®] 成员机构有权撤销"OEKO-TEX[®] CONFIDENCE IN **TEXTILES-OEKO-TEX®** ORGANIC COTTON-通过有害物质检验"标签授 权,并立即生效。现有的宣传资料、展示品、标签 等只限在授权撤销后两个月内继续使用。

但是,若在品质监控检测中发现检测结果严重偏离基础/要求限量值,检测机构或 OEKO-TEX®秘书处有权根据情况撤销已颁发的证书并撤销产品使用OEKO-TEX® ORGANIC COTTON 标签的授权,并立即生效。对于此情况,可能会禁止使用现有的宣传资料、展示品、标签等,并且立即生效。

我方知晓,允许检测机构的检查人员按照 OEKO-TEX[®] ORGANIC COTTON 的认证流程对公司进行 拜访和检查,若有违反 OEKO-TEX[®] ORGANIC COTTON 要求和标准(基于申请依据附录 4 或附录 6中的认证要求)的情况发生,分析检测(品质监控 检测)费用和检查相关费用由我方承担。

我方知晓,认证机构或 OEKO-TEX®检查人员有权 按照 OEKO-TEX® ORGANIC COTTON 的认证流程 对我司的质量保证措施进行检查。正常情况下,三 年为一个检查周期;首次检查将在颁发证书之前或



ing to OEKO-TEX[®] STANDARD 100. This control will take place, under normal circumstances, in a three year cycle; the first time before or shortly after issuing the first certificate to our company. The costs of these visits are charged to us. Companies already certified according to OEKO-TEX[®] STeP are exempt from these additional audits and payments.

3 Limit of authorisation

We know that the authorisation to label a product with the mark "OEKO-TEX® CONFIDENCE IN TEX-TILES – STANDARD 100 – Tested for harmful substances" is limited to a maximum of one year.

4 Conformity declaration

We, the producer and/or distributor of a product labelled with the mark "OEKO-TEX® CONFIDENCE IN TEXTILES - STANDARD 100 - Tested for harmful substances" declare on our own responsibility, that the product manufactured and/or sold complies with the conditions/limit values (depending on requested certification either according to Annex 4 or according to Annex 6) of the OEKO-TEX® STANDARD 100 and where required complies with the conditions/limit values of the co-applicable OEKO-TEX® LEATHER STANDARD, which are known to us, with regard to the limit values of harmful substances. We are fully responsible for quality assurance of the certified product. We may delegate parts of the quality assurance to producers, suppliers and importers. In the case of delegation we fully has to acquaint the certifying body with the effectiveness of the relevant quality assurance system.
